

CONDITIONS OF MEMBERSHIP

1. *Persons wishing to become members of the Club, must complete an official application in such form as shall be determined by the Owner from time to time and must be over fourteen years of age*
2. *On acceptance of an application, the applicant will be sent a membership card which will remain the property of the Owner, and upon the termination of membership, for whatever reason, will be returned to the Owner*
3. *Membership is non-transferable*
4. *The Owner or Manager acting on his behalf reserves the right to reject any applications for membership without giving any reasons for so doing. In such cases, any monies will be refunded immediately*
5. *The Owner or Manager reserves the right to refuse renewal of membership, and will not be obliged to give any reason for his decision*
6. *All members and guests must sign-in at the Club reception desk. On each occasion they visit the Club, members must produce their membership card*
7. *Members may be accompanied by one guest and shall be responsible for the appropriate fee. The member introducing the guest will be responsible for the conduct of that person whilst on the Club premises. The member is responsible for ensuring that all costs incurred by the guest are settled before leaving the premises*
8. *Appearance and Behavior. Members will not be admitted to the Club at any time unless correctly attired. All facilities provided must be used in an orderly manner and members should conduct themselves properly so as not to cause offence to others or damage to equipment*
9. *Musical equipment, lilos and any article which the Owner or Manager at his sole discretion considers detrimental to the enjoyment of other members are not allowed within the Club*
10. *Specific instructions are in place for the use of the tanning booth. These must be strictly adhered to. The Owner accepts no liability should patrons fail to observe the instructions and, accordingly, use of the tanning booth will be solely at the risk of members*
11. *No pets are allowed in the Club or Grounds*
12. *No smoking permitted in the health and fitness areas*
13. *No person may use the facilities whilst under the influence of alcohol or drugs. The Owner or Manager may at his discretion refuse access to facilities to any person who in his sole opinion is so influenced*
14. *The Owner accepts no liability for any illness or injury resulting from use of the Club facilities by members, or guests. Equally, the Owner accepts no liability for illness or injury from over exertion, or precipitation or aggravation of a medical condition caused by such use. All persons who use the Club facilities do so on the expressed basis that they acknowledge that the use is at their own risk. It is strongly recommended that patrons seek medical advice before undertaking any exercise in the Club*
15. *Whilst lockers are available, members and their guests are advised not to leave money or valuables in the Club. No responsibility can be accepted for the loss of such items*
16. *The Owner or Management reserves the right to terminate, without notice, the membership of any person without giving reason. It shall be at the sole discretion of the Owner whether or not all or part of the membership fee is refundable in such circumstances. The Owner or Manager shall further have the right, without declaring any reason therefore, to refuse entrance to any person or prevent such a person from using the Club facilities*
17. *The Owner reserves the right to vary the rules, membership and the other fees payable, the opening hours and the facilities available at any time. In addition, the Club may be closed for maintenance work, re-decoration, special functions or in any other circumstances when the Owner may think it necessary to do so. Notice of any change will be displayed on the notice board*
18. *Any dispute which may arise with regard to the interpretation of these rules shall be determined by the Owner of Manager, whose decision shall be final and binding upon all members*
19. *By their membership, members and guests must accept and agree to be bound by the rules of the club. Patrons may be asked to leave the premises or be refused entry if any breach of these Club Rules is noted*
20. *The Club is not responsible for any member's possessions which are stolen on or off the premises. Cars should be locked. Ladies are warned not to leave their handbags unattended*
21. *Public Safety. Members' notice is drawn to the fire exits which are there in the interest of public safety. In the event of an alarm being raised members are asked to comply promptly with any requests from Management*
22. *Members may not bring their own bottles of alcohol, or food, to consume in the Club or Grounds*
