Terms & Conditions

1. Persons wishing to become members of the leisure facilities must complete an application form.
2. On acceptance of an application, the member will have a card available to collect from reception. Upon the termination of your membership, for whatever reason, the membership card is to be returned to the hotel.
3. All memberships are non-transferable.
4. The Owner, or Manager acting on his behalf, reserves the right to reject any applications for new membership or renewal of membership without giving any reasons for doing so. In such cases, any monies will be refunded immediately.
5. All members and guests must sign-in at the hotel reception desk. On each occasion they use the leisure facilities members must produce their membership card to the duty receptionist.
6. Members must bring their own towels to use in the leisure club, towels will not be provided by the hotel.
7. For the comfort and safety of all members and hotel guests, we recommend that children over 7 years of age use their assigned changing rooms. We request that families with children who may be using the changing rooms of the opposite gender are respectful of the privacy of other guests when using this facility.
8. Members may be accompanied by up to 3 guests each day and shall be responsible for the appropriate fees. The member introducing the guests will be responsible for their conduct whilst on the hotel premises. The member is responsible for ensuring that all costs incurred by the guest are settled before leaving the premises.
9. Appearance and Behaviour: Members will not be admitted to the Club at any time unless correctly attired. All facilities provided must be used in an orderly manner and members should conduct themselves properly so as not to cause offence to others or damage to equipment.
10. Musical equipment, inflatables and any articles which the Owner or Manager considers detrimental to the enjoyment of other members or guests are not permitted within the hotel.
11. Dogs are permitted in the lounge and conservatory, as well as outdoor grounds and garden bedrooms.
12. No smoking is permitted in any area of the hotel.
13. No person may use the facilities whilst under the influence of alcohol or drugs. The Owner or Manager may, at his discretion, refuse entry to any person who in his sole opinion is so influenced.
14. The Owner accepts no liability for any illness or injury resulting from use of the hotel facilities by members, or guests. Equally, the Owner accepts no liability for illness or injury from overexertion, or precipitation or aggravation of a medical condition caused by such use. All persons who use the leisure facilities do so on the expressed basis that they acknowledge that the use is at their own risk. It is strongly recommended that patrons seek medical advice before undertaking any exercise in the hotel.
15. Whilst lockers are available, members and their guests are advised not to leave money or valuables in the leisure facilities. No responsibility can be accepted for the loss of such items.
16. The Owner or Management reserves the right to terminate, without notice, the membership of any person without giving reason. It shall be at the sole discretion of the Owner whether or not all or part of the membership fee is refundable in such circumstances. The Owner or Manager shall further have the right, without declaring any reason therefore, to refuse entrance to any person or prevent such a person from using the hotel facilities.
17. The Owner reserves the right to vary the rules, membership and the other fees payable, the opening hours and the facilities available at any time. In addition, the hotel may be closed for maintenance work, re-decoration, special functions or any other circumstances when the Owner may think it necessary to do so. Notice of any change will be displayed on the notice board.
18. Any dispute which may arise with regard to the interpretation of these rules shall be determined by the Owner or Manager, whose decision shall be final and binding upon all members.
19. By their membership, members and guests must accept and agree to be bound by the rules of the hotel. Patrons may be asked to leave the premises or be refused entry if any breach of these Hotel Rules is noted.
20. The hotel is not responsible for any member's possessions which are stolen on or off the premises.
21. Public Safety: Members notice is drawn to the fire exits which are there in the interest of public safety. In the event of an alarm being raised members are asked to comply promptly with any requests from Management.
22. Members may not bring alcoholic drinks or food, to consume in the hotel or grounds.
23. If the member wishes to terminate their membership before it is due to expire, the hotel requires this instruction in writing. If the membership has been pre-paid in full, the hotel will reimburse the cost of any full months remaining on the current membership term. Part months will not be reimbursed.
